  - Stock name and symbol
  - Number of shares being transferred
- For Gifts via Wire Transfer
  - Amount being transferred
  - Fund number and name

To ensure your funds are transferred correctly, please use the FBO (Or For Further Credit to) with the account name and Edward Jones number. There typically is a place for this on the wire documents.
